

Terms and Conditions | Cordelia Cruises

Introduction

This web site and the related web sites contained herein (collectively, the "Site") make available information on cruise, and other transient leisure travel facilities (each a "Property") owned, managed or franchised by the Waterways Leisure Tourism Private Limited and/or its subsidiaries and affiliates (collectively, "LTPL"), and other travel-related or consumer goods and services. The Site, and the services of each of its modules, is offered exclusively by WLTPPL and or its various third party providers and distributors.

The terms and conditions set out below ("Conditions") apply to your use of the Site including the use of the information services offered on the Site.

In accessing, using, viewing, transmitting, caching or storing this Site or any of its services, functions, materials, or contents, you shall be deemed to have agreed to each and all the Conditions and notices in this Site without modification. Further, you agree to be bound by these Conditions so please carefully read this section before proceeding. If you do not accept these Conditions, you must refrain from using the Site. The language of the arbitration shall be English.

The law governing this arbitration agreement shall be law of India."
